#### Conservation Update: Bob C.

- a. Fish Rescue tentative totals: ~4,700 fish rescued from the canals to date. Final tallies will be given Monday 11/14/11. Potentially, an all time number rescued.
- b. One of the most encouraging areas this year is from Lake View canal. 556 fish saved, double that from last year, shows signs of successful spawning.
- c. Bob Capron will no longer be heading up this Canal salvage
- d. Need help and need to find someone or somebodies to take over.

- Electroshock Technician Certification

#### Duties:

- Need help with media contacts, volunteer organization, school kids etc.

**New Business—**



Save the Yellowstone Cutthroat. Update on acoustic tag purchases

- a. Dave S. traveled across the state and gave three presentations similar to those that we saw at our meeting on the SYCT project. In all, an additional \$5,000 was raised to purchase additional equipment.
- b. Currently there are 141 fish tagged with 41 receivers in Yellowstone Lake
  - the goal is to tag 350 fish and have 80 receivers. That cost is about \$180,000.
  - the bare bones minimum they would like to reach would cost about \$85,000 which accounts for 250 tags with 40 receivers.



George S motioned that we recommend to the board that EYTU Chapter give \$3,000 to Save the Yellowstone Cutthroat fund. Birney 2<sup>nd</sup>. Motion passed.



Dave S. donated art work (metal fish) to the Save the Yellowstone Cutthroat fundraising activities.



Million Pipeline:

- a. Developer Aaron Millions want to take 81 billion gallons/yr out of the Green river and Flaming Gorge and pipit it 560 miles to the Colorado Front Range.
